- Giving by PAR is a mindful, convenient way to take care of your commitment to St. Andrew's.
- PAR provides a consistent stream of funding that St. Andrew's knows will be available every month, whether you are able to attend worship services or not.
- Donors can contribute to the general operating fund as well as Mission and Service as well as any ongoing capital campaigns. These amounts can be changed at any time should you wish to increase or decrease your giving.
- There is no charge to the contributor for using PAR.

## PRE-AUTHORIZED REMITTANCE (PAR)

If you would like to use PAR, the current information and application form are on the reverse side of this information. Please complete and return it to the church office, or place it with a VOID cheque in an envelope on the offering plate, marking envelope "Confidential: Treasurer".

If you have automatic payments withdrawn from your bank account to pay for your heat, hydro, taxes, cable TV, insurance, etc., then you know the PAR principle. It means regular contributions throughout the year.

Many people use the PAR system for their Church offering, finding it a convenient way to take care of their regular commitments to the Church month by month. You can participate in this program. A debit is withdrawn from your account on or about the 20th of each month, and St. Andrew's receives the total amount payable from all members who participate.

- I/we may revoke my/our authorization at any time, subject to providing notice of 15 days at which time I/we will submit a cancellation form obtained from the Church Treasurer or by contacting my/our financial institution
- I/we have certain recourse rights if any debit does not comply with this agreement. For example, I/we have the right to receive reimbursement for any debit that is not authorized or is not consistent with this PAR agreement. To obtain more information on my/our recourse rights, I/we may contact my/our financial institution.
- I/we waive my/our right to receive pre-notification of the amount of the Pre-Authorized Remittance (PAR) and agree that I/we do not require advance notice of the amount of PAR before the debit is processed.

\$5.00 weekly = \$21.65 monthly = \$260.00 annually

\$10.00 weekly = \$30.31 monthly = \$364.00 annually

\$15.00 weekly = \$64.95 monthly = \$780.00 annually

\$20.00 weekly = \$86.60 monthly = \$1,040.00 annually

\$30.00 weekly = \$129.90 monthly = \$1,560.00 annually

\$40.00 weekly = \$173.20 monthly = \$2,078.00 annually

\$50.00 weekly = \$216.50 monthly = \$2,600.00 annually

\$75.00 weekly = \$324.75 monthly = \$3,900.00 annually
